### SHIPPING METHOD

- Check box & multiply P&H % times RV subtotal.*
- GROUND — \$10 (ALL ORDERS UNDER \$200)
  - GROUND — 5% (ORDERS \$200-\$499.99)
  - GROUND — 4% (ORDERS \$500-\$1499.99)
  - GROUND — 3% (ORDERS \$1,500-\$2999.99)
  - GROUND — 2% (ORDERS \$3,000 & OVER)
  - 2ND DAY — 15% (MINIMUM - \$15.00)
  - NEXT DAY — 20% (MINIMUM - \$20.00)
